





**SUBJECT:** 

**Redistricting of Current Electoral Districts** 

**BACKGROUND:** 

Boundaries for the City of Goldsboro's six current Electoral Districts were last revised and amended on July 5, 2011 in order to more accurately balance population changes experienced as a result of the 2010 Census.

With new data becoming available based on the 2020 Census, there is now a population imbalance within the City's current Electoral Districts which may affect equal representation for its citizens and the one person, one vote principle guaranteed in the United States Constitution.

**DISCUSSION:** 

In order to ensure equal representation, it is proposed that the City contract for redistricting of its Electoral Districts.

Redistricting would entail adoption of new Electoral District maps which would reflect 2020 Census data and ensure a balance of population in each District.

By recommendation of the UNC School of Government, City Staff proposes to contract with Poyner Spruill and Marshall Hurley, PLLC to serve the City of Goldsboro with redistricting the City's electoral districts following the 2020 Census.

Poyner Spruill and Marshall Hurley, PLLC will represent the City by providing legal advice concerning the application of various statutes and legal precedent to the redistricting process. They will perform this engagement through a specific package of services and will be consistent with the goals of the Local Redistricting Service, A Project of North Carolinians for Redistricting Reform, a bipartisan non-profit dedicated to improving democracy through redistricting reform. The Local Redistricting Service provides an open, nonpartisan redistricting process consistent with the goals of North Carolinians for Redistricting Reform.

As part of the engagement, a professional demographer will analyze census data and prepare draft maps for the City. The Demographer will work independently of Poyner Spruill and Marshall Hurley, PLLC in analyzing the City's demographic data and drafting proposed electoral maps based on that data, while Poyner Spruill and Marshall Hurley, PLLC will only be responsible

for providing legal advice in connection with redistricting and the proposed maps.

Poyner Spruill and Marshall Hurley, PLLC have agreed to provide their legal services for a flat fee of \$7,500 and the Demographer has agreed to provide his services for a flat feet of \$10,000, for a total charge to the City of \$17,500.00.

Standard package in the amount of \$17,500 allows for the following services:

- Unlimited phone and email consultations with Lawyers during plan development;
- Up to three visits by Lawyers and two visits by Demographer to the jurisdiction;
- Development of redistricting plan by Demographer, with a legal review by Lawyers, using redistricting software, including the creation of up to three alternative plans;
- Lawyers will prepare any resolutions, ordinances, or other documents needed to accomplish the redistricting; and
- The Demographer will export final plan electronically to City GIS system, County Board of Elections, or other relevant entity, if requested.

Understanding the City of Goldsboro will not hold municipal elections next year, unlike some other municipalities, Poyner Spruill and Marshall Hurley, PLLC proposes a customized schedule to carry out the redistricting process. Suggested meeting scheduled is an initial meeting to discuss the redistricting process, analyze demographic data, and solicit input from council members in the fall of 2021, a second meeting to discuss proposed redistricting plans beginning January 2022 and conclude with a third meeting to conduct a public hearing and/or adopt final resolution approving the redistricting plan early next year.

The Planning Director and Finance Director have reviewed the fee proposal for this project. Sufficient funds are available for the consultant services and budgeted within the FY22 Planning Department budget.

RECOMMENDATION: By motion, adopt a Resolution authorizing the Mayor and City Clerk to execute a contract in the amount of \$17,500.00 with Poyner Spruill and Marshall Hurley, PLLC, for the engagement of

legal services in connection with redistricting the City's electoral districts following the 2020 census.

Councilmember Broadaway made a motion to vote, Councilmember Aycock seconded the motion. Council discussed the item. 



#### Public Hearings.

Z-9-21 Paul Vinson III (HB - GB) – South side of 11th Street at the intersection of 11th Street and N William Street. Public Hearing Held. The applicant owns the subject property. The majority of the property is zoned Highway Business (HB). A portion of the property is zoned General Business (GB).

The applicant requests to rezone the entire property to General Business (GB) for commercial development purposes. If the property is rezoned, site and landscape plans will be required and approved by City officials before construction permits can be issued in the future.

Frontage: 280 ft. (11th St.)

Area: 20,467 sq. ft. or 0.47 acres

North: Residential (R-6), General Business (GB); South: Highway Business/General Business (HB/GB)

Residential/Manufactured Non-Conforming (RM-NC)

East: Highway Business (HB/RM-NC); and

West: General Business (GB)

The subject property is clear and vacant.

The City's Land Use Plan recommends Commercial development for the property.

The subject property is not located in a Special Flood Hazard Area. City water and sewer utilities are available to serve the property.

Mayor Pro Tem Ham opened the Public Hearing.

1. Mack Burns Jr., Eleventh Street, inquired as to what type of business would be located in the area in question. Council, Ms. Collins and Mr. Burns discussed the proposed uses.

No one else spoke and the Public Hearing was closed.

No action necessary. The Planning Commission will have a recommendation for Goldsboro City Council at their regularly scheduled meeting on September 7, 2021.

Analysis of Impediments & Assessment of Fair Housing Choice Public Hearing. Public Hearing Held. As required by HUD, the Community Relations Department sought an agency to complete an Analysis of Impediments to Fair Housing through a Request for Proposal process. UNC-Greensboro's Center for Housing & Community Studies completed the report and provided a final draft of the analysis to City staff on May 1, 2021.

This project involved compiling, analyzing, and mapping local jurisdictional, state, and national data sources on residential housing disparities for the seven federally protected categories: Race, Color, Religion, Sex, Handicap, Familial Status, and National Origin.

Staff will highlight the six notable impediments and recommendations. The Community Relations Department will take appropriate actions necessary to overcome the effects of the impediments identified through the analysis.

Felecia Williams, Interim Community Relations Director shared the following presentation:

#### Analysis of Impediments & Assessment of Fair **Housing Choice**



#### Introduction..

- The Department of Housing & Urban Development (HUD) requires that recipients of HUD funds conduct an Analysis of Impediments (Al) to Fair Housing Choice every five years.
- five years.

  The City of Goldsboro, being a recipient of federal block grant funds from the U.S.

  Department of Housing & Urban Development (HUD), must certify that it will
  affirmatively further fair housing by committing to conduct an analysis to identify
  impediments to fair housing holde within the jurisdiction, take appropriate
  actions to overcome the effects of any impediments identified through that
  analysis, and maintain records reflecting the analysis and actions in this regard.
- The preparation of this Analysis of Impediments to Fair Housing Choice (Al) server as a component of the City of Goldsboro's efforts to satisfy the requirements of the Housing & Community Development Act of 1974.
- Additionally, communities receiving HOME funds are required to: 1) Examine and attempt to alleviate housing discrimination; 2) Promote fair housing choice for all 3) Promote housing accessible to and usable by persons with disabilities; 4) Comply with the non-discrimination requirements of the Fair Housing Act.

#### Background..

- ➤ The City of Goldsboro initiated a request for proposals in late 2019 and fully executed a contract on July 9, 2020 with the University of North Carolina at Greensboro's Center for Housing and Community Studies.
- The project was conducted over an eight month period (June 2020 to February 2021) with a final draft provided to City Staff in May 2021.
- The AI was made available to the public on July 16, 2021 and include a 2-week public comment period that ended on July 30, 2021. Two written comments were received from Habitat for Humanity and Wayne Forward.

#### Data Sources & Methods

- Other statistical analyses

- ► Telephone and Zoom interviews
  ► Four public stakeholder meeting

#### Impediments & Goals

Impediment 1: Lack of Affordable Rental Housing

Lack of affordable rental housing arose repeatedly in the data. Nearly half of renters (47%) were cost burdened, paying more than 30% of their income towards rent. Housing affordability was repeatedly discussed in interviews, clear in survey data, and throughout the secondary data analysis.

Goal 1: Promote Preservation of Existing and Development of New Affordable Rental Housing

Promote and encourage the development of affordable market rental housing units especially for households whose income is less than 80% of the Area Median Income.

#### Impediments & Goals

Impediment 2: Lack of Affordable Housing for Sale Lack of affordable single-family housing was also found in the data.

Goal 2: Promote and encourage the development of for-sale single family houses for low-and-moderate income households

Continue to support down-payment assistance programs and mortgage financing to low-income homebuyers, support rehabilitation of existing owner-occupied housing, increase homebuyer education, support non-profit developers, etc.



Mayor Pro Tem Ham opened the Public Hearing the following people spoke:

- 1. Kaelon Williams spoke about affordable housing and a specific set of people. Council discussed affordable housing, home ownership, lending institutions, census tracts and the homelessness board.
- 2. Dr. David Craig, 509 Shelley Drive, spoke about city policies, HOME funds, change and Council.
- 3. Alicia Pierce, 806 S. Taylor Street, spoke about advertising to reach more citizens to get funding for housing and breaking out the Community Relations Department into two positions.
- 4. Dr. David Craig spoke about the city using federal dollars, policies and affordable housing.

No one else spoke and the Public Hearing was closed.

No action is necessary. The Community Relations Interim Director will send the Analysis of Impediments & Assessment of Fair Housing Choice to HUD as required after the public hearing. A report will be submitted to HUD of any comments made by the public.

- 6. Yvonnia Moore shared comments concerning race and leadership.
- 7. Thomas Rice shared comments concerning his family, unity and respect.
- 8. Sylvia Barnes shared comments concerning the District 5 seat.
- 9. Nadine Mceachern thanked council for what they do.

No one else spoke and the public comment period was closed.

Councilmember Aycock had no comments.

WHEREAS, North Carolina General Statute § 160A-269 permits the city to sell real property by upset bid, after receipt of an offer for the property; and

WHEREAS, the City has received an offer to purchase the property described above, in the amount of \$5,445.00 (Five Thousand Four Hundred Forty Five Dollars and no/100) submitted by Community Technical Assistance, Inc. (Offeror); and

WHEREAS, Offeror has paid the required five percent (5%) deposit on his/her offer in the amount of \$272.25 (Two Hundred Seventy Two Dollars and 25/100);

NOW THEREFORE BE IT RESOLVED, by the City Council of the City of Goldsboro, North Carolina, that:

- 1) The City council declares this property as surplus.
- 2) The City Council authorizes sale of the property described above through the upset bid procedure of North Carolina General Statute § 160A-269.
- 3) The Finance Director shall cause a notice of the proposed sale to be published in a newspaper of general circulation within its jurisdiction. The notice shall describe the property and the amount of the offer, and shall state the terms under which the offer may be upset.
- 4) Persons wishing to upset the offer that has been received shall submit a sealed bid with their offer to the office of the Finance Director at 200 N. Center Street, Goldsboro, NC 27530 during normal business hours within 10 days after the notice of sale is published. At the conclusion of the 10-day period, the Finance Director shall open the bids, if any, and the highest such bid will become the new offer. If there is more than one bid in the highest amount, the first such bid received will become the new offer.
- 5) Upset offer and deposit shall be delivered in a sealed envelope. The written offer proposal must include the name of the person or business making the offer, address of said property, and Wayne County parcel identification number with the signature of the person placing the offer. The City of Goldsboro reserves the right to reject any or all offers at any time.
- 6) If a qualifying higher bid is received, the Finance Director shall cause a new notice of upset bid to be published, and shall continue to do so until a 10-day period has passed without any qualifying upset bid having been received. At that time, the amount of the final high bid shall be reported to the City Council.
- 7) A qualifying higher bid is one that raises the existing offer by not less than ten percent (10%) of the first \$1,000.00 of that offer and five percent (5%) of the remainder of that offer.
- 8) A qualifying higher bid must also be accompanied by a deposit in the amount of five percent (5%) of the bid; the deposit may be made in cash, cashier's check, or certified check. The city will return the deposit on any bid not accepted, and will return the deposit on an offer subject to upset if a qualifying higher bid is received. The city will return the deposit of the final high bidder at closing.
- 9) The terms of the final sale are:
  - a) City Council must approve the final high offer before the sale is closed, which it will do within 30 days after the final upset bid period has passed.
  - b) The Wayne County Board of Commissioners must approve the final sale by concurrence after final approval by City Council.
  - c) Buyer must pay with cash or certified funds at the time of closing.
  - d) Buyer must pay closing costs.
- 10) The City reserves the right to withdraw the property from sale at any time before the final high bid is accepted and the right to reject at any time all bids.
- 11) If no qualifying upset bid is received after the initial public notice, the offer set forth above is hereby accepted. City staff is authorized to seek concurrence from the Wayne County Board of Commissioners and upon such approval, the appropriate city officials are authorized to execute the instruments necessary to convey the property to Offeror.

SUBJECT:

Approve or Decline Selling the Miniature Train in Herman Park

**BACKGROUND:** 

The City of Goldsboro has an agreement with the Kiwanis Club of Goldsboro in regards to the miniature train the City owns located in Herman Park. The agreement allows the Kiwanis Club of Goldsboro to operate the train and charge admission fees. In return, the Kiwanis Club of Goldsboro is responsible for the maintenance and upkeep of the miniature train – setting aside a portion of their proceeds to be specifically used for train maintenance.

The miniature train was manufactured in 1953, purchased in 1955 and is one of only about 275 that were made. The last miniature train of this type was manufactured in 1963. Replacement parts are becoming harder for the Kiwanis Club of Goldsboro to obtain. The miniature train will need to be replaced soon.

**DISCUSSION:** 

During their August 16, 2021 presentation, the Kiwanis Club of Goldsboro presented a solution to City Council. Allow the Kiwanis Club of Goldsboro to raise funds to purchase a new miniature train for Herman Park. The Kiwanis Club of Goldsboro will then donate the new miniature train to the City of Goldsboro – it will become City property.

The Kiwanis Club of Goldsboro asked the City Council to contribute the proceeds from selling the 1953 miniature train towards the new train replacement, should Council decide to sell the current miniature train located in Herman Park.

RECOMMENDATION:

It recommended that City Council by motion:

- 1. Approve or decline the selling of the miniature train.

SUBJECT:

Request authorization to modify FY 2020/21 equipment purchases.

BACKGROUND:

Due to equipment price increases, priority changes and administrative oversight, funds available through debt borrowing are insufficient to cover the cost of equipment approved to purchase during the FY 2020/21 budget process. Forgoing purchasing the Leaf Truck/Leaf Machine would free up \$135K to overcome the shortfall and enable the purchase of higher priority equipment.

DISCUSSION:

An F-350 Service Body Truck, Equipment Tilt Trailer and Dumpster Carrier Trailer were authorized to be purchased through the FY 2020/21 budget process, but not included in the debt borrowing. The F-350 is a replacement for one totaled in an accident-City employee was not at fault. The F-350 truck, as well as the Equipment Tilt Trailer, are needed to pull the street maintenance crew's new excavator to and from jobsites. With regard to purchasing a dumpster carrier trailer, it would be insufficient and impractical for the number of dumpsters being rented, relocated, and serviced throughout the City and Seymour Johnson AFB and needs to be upgraded to an actual Dumpster Carrier Truck. It would increase capabilities to meet current demands and be more efficient.

The \$135K made available from not purchasing the Leaf Truck/Leaf Machine will cover the costs of the aforementioned equipment, as well as other material and manufacturer cost increases we have experienced due to the delay.

RECOMMENDATION:

By motion, approve using funds originally set forth to purchase the Leaf Truck/Leaf Machine to purchase the F-350 Service Body Truck, Equipment Tilt Trailer, Dumpster Carrier Truck and offset other equipment price increases.





### ORDINANCE NO. 2021-

### AN ORDINANCE AMENDING CHAPTER 130 ENTITLED "OFFENSES AGAINST CITY REGULATIONS" SECTION 130.07 CONCEALED HANDGUNS OF THE CODE OF ORDINANCES OF THE CITY OF GOLDSBORO, NORTH CAROLINA

WHEREAS, the Code of Ordinances includes a section related to Concealed Handguns; and

WHEREAS, Chapter 130 entitled "Offenses Against City Regulations" Section 130.07 Concealed Handguns currently describes the rules for concealed handguns in city owned buildings and on city owned property; and

**WHEREAS**, staff would recommend Council update Section 130.07 entitled "Concealed Handguns" to completely re-write the section regarding concealed handguns of the Code of Ordinances of the City of Goldsboro, North Carolina.

**NOW, THEREFORE, BE IT ORDAINED** by the City Council of the City of Goldsboro, North Carolina, that Chapter 130 entitled "Offenses Against City Regulations" Section 130.07 Concealed Handguns of the Code of Ordinances of the City of Goldsboro, North Carolina, be and is hereby amended in its entirety as follows:

### § 130.07 CONCEALED HANDGUNS.

- (A) No person shall carry a concealed handgun or other dangerous weapon on or within any city-owned building and/or their appurtenant premises or in any city-owned park. An appropriate notice of the prohibition shall be posted in a conspicuous place in each city-owned building, their appurtenant premises and in each city park notifying persons of the prohibition against carrying a concealed handgun therein.
- (B) This chapter shall not apply to law enforcement or other government personnel acting within the scope of their employment.

§ 130.07 PROHIBITION OF THE CARRYING AND DISPLAY OF HANDGUNS, FIREARMS AND OTHER WEAPONS AT CERTAIN PUBLIC LOCATIONS.

### (A) Concealed handguns.

- 1. Possession prohibited. No person shall carry a concealed handgun or other dangerous weapon on or within any city-owned building and/or their appurtenant premises or in city recreational facilities as defined by G.S. 14-415.23, which are all city athletic fields and athletic facilities. A list of recreational facilities shall be set out in a Schedule of Recreational Facilities at which Concealed Handguns are Prohibited which shall be updated as necessary and retained permanently in the office of the Director of Parks and Recreation. Notwithstanding the foregoing, nothing in this section shall prohibit a concealed handgun permittee from securing the handgun within an enclosed compartment of a locked motor vehicle.
- 2. An appropriate notice of the prohibition shall be posted in a conspicuous place in each city-owned building and/or their appurtenant premises and in city recreational facilities as defined by G.S. 14-415.23 notifying persons of the prohibition against carrying a concealed handgun therein.

### (B) Other firearms and weapons.

- 1. No person shall display any firearm in public-owned buildings, on the grounds or parking areas of those buildings, or in public parks and recreation areas, including city greenways. On all other public property within the city, including public streets, alleys, and sidewalks, display of firearms shall comply with the following:
  - (a) no firearms other than handguns, as defined in G.S. 14-409.39, may be displayed;
  - (b) the handgun shall be holstered such that firing of the weapon is not possible;
  - (c) the handgun shall be clearly visible and not concealed or partially concealed;
  - (d) display of handguns is prohibited for any person while consuming alcohol or at any time while the person has remaining in the person's body any alcohol or in the person's blood a controlled substance previously consumed, but a person does not

- violate this condition if a controlled substance in the person's blood was lawfully obtained and taken in therapeutically appropriate amounts;
- (e) display of handguns is prohibited on any public streets, including adjacent sidewalks, that have been closed by the chief of police or designee pursuant to Section 98.80.
- 2. No person shall display any deadly weapon as defined in G.S. 14-269(a), or any knife having a blade of three inches or longer, BB gun, air gun, paintball gun, airsoft gun, bow and arrow or any type of lethal weapon, while on any public street, alley, sidewalk or other public property within the town, including town greenways, unless specifically permitted or authorized by law. No person shall carry or have possession of a knife having a blade of three inches or longer, a BB gun, air gun, paintball gun, airsoft gun, bow and arrow or any type of lethal weapon in any park, including city greenways.
- 3. This subsection (B) is not applicable to concealed handguns, which are governed by subsection (A) above.
- (C) Exceptions. The possession or display of a firearm or other weapon is exempt from the provisions of this Section 130.07 in the following situations:
  - 1. If the chief of police, or designee, has authorized the public possession or display of a firearm, or other weapon, as part of an official program or event sponsored or sanctioned by the town.
  - 2. If the possession or display of the firearm, or other weapon, was the result of an individual(s) exercising his or her legitimate right to self-defense or the defense of others as allowed by law.
  - 3. If the possession or display of the firearm, or other weapon, was conducted by a person(s) authorized by law to carry and display such items as part of their official or otherwise recognized lawful duties (e.g., law enforcement officers, military personnel, security guards, etc.).
  - 4. If the possession or display of the firearm, or other weapon, was necessary for the temporary transport and securing of the item and was not otherwise in violation of existing statutes or ordinances (e.g., recent purchase and movement to vehicle for transport, securing of firearm by CCH permit holder in vehicle, found item to be turned in to authorities, firearm in approved vehicle gun rack, etc.).
  - 5. The possession or display of a knife with a blade longer than three inches for the performance of the duties of a town employee or contractor.
- (D) Violation. The carrying of concealed handguns or the possession or display of any firearm or other weapon as defined in this section, in or upon any of the locations specified by this section, shall constitute a misdemeanor and subject any violator(s) so convicted to such penalties as may be imposed by the court.

# AN ORDINANCE AMENDING CHAPTER 97 ENTITLED "PARKS AND RECREATION" SECTION 97.05 FIREARMS OF THE CODE OF ORDINANCES OF THE CITY OF GOLDSBORO, NORTH CAROLINA

WHEREAS, the Code of Ordinances includes a section related to Firearms; and

WHEREAS, Chapter 97 entitled "Parks and Recreation" Section 97.05 Firearms currently describes Firearms as it relates to Parks and Recreation; and

WHEREAS, staff would recommend Council update Section 97.05 entitled "Firearms" to add a statement concerning Section 130.07 of the Code of Ordinances of the City of Goldsboro, North Carolina.

**NOW, THEREFORE, BE IT ORDAINED** by the City Council of the City of Goldsboro, North Carolina, that Chapter 97 entitled "Parks and Recreation" Section 97.05 Firearms of the Code of Ordinances of the City of Goldsboro, North Carolina, be and is hereby amended as follows:

### § 97.05 FIREARMS.

- (A) Except as is stated in §130.07, it # shall be unlawful for any person, except duly authorized Parks and Recreation Department employees, park officials or law enforcement officers in the course of their duty to discharge, shoot, fire or explode, or cause to be discharged, shot, fired or exploded any firearm including, but not limited to air rifles, toy pistols, toy guns or other toy arms designed to forcibly hurl a projectile or missile at any time or under any circumstances within any park, or to carry any firearms or dangerous weapons in any park. "Weapons" shall include knives with a blade greater than four inches in length, brass knuckles, clubs, or any item specifically designed to inflict bodily harm.
- (B) It shall be unlawful for any person to carry or to explode any explosive device, to include fireworks, sparklers, smoke bombs, firecrackers, roman candles, etc., in any park unless written authority is given by the Parks and Recreation Director.

This Ordinance shall be in full force and effect from and after the 7<sup>th</sup> day of September, 2021.
