Dear Mr. Salmon:

The American Rescue Plan Act of 2021 appropriated \$5 billion to provide housing, services, and shelter to individuals experiencing homelessness and other vulnerable populations, to be allocated by formula to jurisdictions that qualified for HOME Investment Partnerships Program allocations in Fiscal Year 2021. On September 13, 2021, the Department published CPD Notice 21-10, titled: *Requirements for the Use of Funds in the HOME-American Rescue Plan Program* (the Notice), which you are encouraged to review to assist in developing your program. As the participating jurisdiction (PJ), you are responsible for ensuring that all grant funds are used in accordance with all program requirements.

In accordance with the Notice, and the HOME ARP Grant Agreement, a PJ, as of the Federal Award Date, may use up to five percent of its total award for administrative and planning costs before HUD accepts its HOME-ARP Allocation Plan. Your HOME-ARP Allocation Plan has been accepted by HUD and the remaining award will be made available.

As a reminder, the PJ must adhere to the referral methods detailed in the HOME-ARP notice (Section IV.C.) for all assisted projects which are: the coordinated entry (CE) system established by the Continuum of Care serving its geographic area; a combination of coordinated entry with other referral methods, or a project activity waiting list. If the PJ elects to utilize the CE system, the CE system must be revised to accept the qualifying populations eligible for activities or projects it intends to fund, in accordance with the preferences and prioritization, if any, described in its HOME-ARP allocation plan.

If you have not yet submitted a copy of your signed HOME-ARP Grant Agreement to this office, please do so immediately. In response to COVID-19, HUD authorizes you to electronically execute the grant agreement with your electronic signature. Execute two (2) copies with electronic signatures and, return one (1) of the agreements to this office to the attention of Matthew T. King, CPD Director at matthew.t.king@hud.gov. Maintain a copy of the agreement with your original signature on site in your program files.

Introduction

In September 2021, the U.S. Department of Housing and Urban Development announced the allocation of \$907,913 to the City of Goldsboro for a new grant called the Home Investment Partnerships Grant - American Relief Plan (HOME-ARP). The purpose of the HOME-ARP funds is to provide homelessness assistance and supportive services through several eligible activities. Eligible activities include acquisition and development of non-congregate shelter, tenant based rental assistance, supportive services, development of rental housing, administration and planning, and nonprofit operating and capacity building assistance. The HOME-ARP funds must assist those in "qualifying populations", which include:

- Sheltered and unsheltered homeless populations
- Those currently housed populations at risk of homelessness
- Those fleeing or attempting to flee domestic violence or human trafficking
- Other families requiring services or housing assistance or to prevent homelessness
- Those at greatest risk of housing instability or in unstable housing situations

In accordance with HUD requirements, the City has prepared the following Allocation Plan that describes the process of consulting with local agencies, analyzes the needs of populations who are unhoused or experiencing housing insecurity, and proposes a spending plan for HOME-ARP.

Consultation

Summarize the consultation process:

Several community consultations were held in preparation of this Allocation Plan. Local organizations were invited to attend working group sessions to discuss needs surrounding the homeless populations. The organizations consulted are identified in the table below. During the consultations, the HOME-ARP eligibility and allocation plan process was described. Organizations were asked to share what gaps or needs exist within Goldsboro, as well as their opinion of groups in greatest need of housing assistance.

Describe any efforts to broaden public participation:

Public participation is a critical component to community planning efforts. As such, the City of Goldsboro provided both an in-person and virtual option for residents to submit feedback on the Allocation Plan. This enabled those with and without internet and with and without flexible schedules to provide their input. The details of the public participation were posted on the City website, Facebook page, and posted in the local paper to reach as many community members as possible. An online survey was also offered as part of the public participation process. This offered community members an opportunity to provide input into the Allocation Plan if they could not attend the Public Hearing. The survey was open for 15 days, beginning on the day of the Public Hearing, extending to December 5, 2022. The virtual feedback form included potential allocation plans and then offered 7 multiple choice questions, along with two open-ended questions, where respondents had the opportunity to share any other thoughts not already captured.

Online Survey Results

Thirty responses were received: 59% of which came from individuals who did not attend the Public Hearing. 40% of the respondents were people experiencing or have experienced homelessness. 17% of the respondents were local city or county officials. The remaining 33% were community members, some of which were part of local CoCs.

The survey asked all respondents to rank the eligible activities from highest priority to lowest. 75% of the respondents identified Non-Congregate Shelter as the highest area of need in Goldsboro.

The survey showcased three options for an Allocation Plan. 68% of the respondents chose the Allocation Plan that utilized 59% of the funds on Non-Congregate Shelters and the remainder on mostly Supportive Services and TBRA.

Table 1 Narrative

According to the NC-503 Balance of State CoC Housing Inventory Count, there are currently only 3 units providing 11 beds specifically designated for victims of domestic violence who have children. Additionally, there are only 6 beds for individual adults specifically designated for victims of domestic violence, all offered by a local agency. The data further informs that a State of NC Agency (NC Commission of Indian Affairs) has 'Other Permanent Housing' available by way of what is presumed to be 34 housing vouchers for individual adults, 3 units with 8 beds for families with children, all of which are specifically designated for NC American Indians.

Regarding the 'Homeless Population' count in Table 1, the 'Sheltered Homeless' are identified as 17 victims of domestic violence who are currently being served by the 11 available family beds and 6 individual beds by the local domestic violence agency.

The 2022 Point in Time Count indicates that there are a total of 14 homeless individuals in Wayne County, with 12 residing in emergency shelters and 2 unsheltered. It is important to note that the Point in Time Count is conducted annually on a single night during the last ten days in January and may not be inclusive of the true number of homeless individuals in Goldsboro, Wayne County. Additionally, the Goldsboro Police Department provided data reflective of unsheltered homeless individuals within the city limits of Goldsboro at a total of 29. The Goldsboro Police Department routinely conducts a real-time foot patrol count of unsheltered homeless that are in the city limits of Goldsboro and recently concluded the following: 18 individuals confirmed as living in a local 'tent city,' 5 additional unsheltered individuals live in wooded areas near local establishments, and 6 individuals reside in their vehicles in local parking lots.

In conclusion, with a total of 31 unsheltered homeless individuals in Goldsboro and there only being 2 organizations providing shelter, designated to specific groups, the data shows the apparent gap in available shelter beds for homeless individuals and an urgent need for a Non-Congregate shelter in Goldsboro.

Size and Demographic composition of qualifying populations within Goldsboro

According to the 2022 Point in Time data in Table 1, there are 12 sheltered individuals in Goldsboro/Wayne County.

Homeless

Of the total 31 homeless individuals, all 31 are unsheltered. 18 individuals are confirmed to be living in the tent city community with an additional 5 living in other wooded areas throughout the community, according to data from the Goldsboro Police Department. 6 individuals were reported as living in their cars in local parking lots. Lastly, 2 individuals identified in the Point In Time count are unsheltered and counted in this qualifying population. Unfortunately, a lack of coordinated services makes it difficult to identify an accurate estimate of the number of households in this qualifying population. Thus, there is no demographic information available.

At-risk of homelessness

Information obtained from the American Community Survey (ACS) and the Comprehensive Housing Affordability Strategy (CHAS), as identified in Table 2 above, indicates that there are 1,245 renter households earning 0-30% of the area median income that are at risk of homelessness. Additional demographic data is not available for this qualifying population.

<u>Fleeing/Attempting to Flee Domestic Violence, Dating Violence, Sexual Assault, Stalking, or Human Trafficking</u>

A third population in Table 1 is those Fleeing or Attempting to flee domestic violence, dating violence, sexual assault, stalking, or human trafficking. Data represents this population at a total of 17. It is important to recall that this population is currently served by a local domestic violence agency. Although the Homeless Needs and Gaps Analysis at Table 1 identifies 17

households as meeting this qualifying population, this in no way identifies the total number of households identified in the community. Unfortunately, a lack of coordinated services makes it difficult to identify an accurate estimate of the number of households in this qualifying population. Thus, there is no demographic information available.

Other Populations

Information obtained from the American Community Survey (ACS) and the Comprehensive Housing Affordability Strategy (CHAS), as identified in Table 2 above, indicates that there are 1,325 renter households earning 30-50% of the area median income that are at risk of homelessness. Additional demographic data is not available for this qualifying population.

Describe the unmet housing and service needs of qualifying populations:

Homeless –

Goldsboro/Wayne County's sheltered homeless are in dire need of more permanent housing solutions in the area. With the ever-present lack of affordable housing for low-moderate-income individuals nationwide, HOME-ARP Supportive Services dollars can assist the sheltered with gaining the needed resources required to establish permanent housing. The Region 10 Balance of State Continuum of Care provides a Coordinated Entry process that can assist sheltered individuals with assessing their housing needs. The CoC also provides Emergency Solutions Grants (ESG), a program focused solely on permanent housing solutions.

It is apparent that the unsheltered face a distinct set of challenges that require an immediate solution. With Goldsboro's limited shelter resources for the 31 unsheltered, the need for an emergency shelter is dire. Goldsboro is no stranger to emerging 'Tent Cities' and is currently struggling to assist the identified 18 unsheltered individuals confirmed to be living in Goldsboro's own tent city. The Goldsboro Police Department continues to make strides to link these individuals to the few local resources that are available. The department recently cleaned out the illegal site; however, many residents returned shortly after and currently remain there. A Non-Congregate Shelter is desperately needed.

• At risk of homelessness-

As there is currently no local coordinated entry established in Goldsboro, this qualifying population could benefit from such supportive services. Goldsboro currently has a need for coordination of services and could benefit from a local coordinated system in which households/individuals of this qualifying population can be referred to the appropriate housing resources.

• Fleeing/Attempting to Flee Domestic Violence, Dating Violence, Sexual Assault, Stalking, or Human Trafficking-

Overall, there is a great need for affordable housing that can help prevent homelessness for this population. Additionally, Goldsboro could benefit from additional resources such as rental assistance and more rental housing vouchers to assist other families requiring services, per consultations from local agencies. Lastly and again, Goldsboro currently has a need for coordination of services and could benefit from a local coordinated system in which households/individuals of this qualifying population can be referred to the appropriate housing resources.

• Other Populations –

Again, Goldsboro currently has a need for coordination of services and could benefit from a local coordinated system in which households/individuals of this qualifying population can be identified and referred to the appropriate housing resources.

Identify and consider the current resources available to assist qualifying populations, including congregate and non-congregate shelter units, supportive services, TBRA, and affordable and permanent supportive rental housing:

Currently, Goldsboro has 1 local shelter, provided by a church, that charges a small weekly fee for occupancy. Goldsboro does not have any non-congregate shelter units. Another local men's shelter, operated by The Salvation Army, has been closed for the past three years. Efforts to assist the new leaders of the organization to reopen the shelter with other available HUD dollars have been unsuccessful. Goldsboro has local agencies who provide food, clothing, laundry needs, link to mental health and substance abuse resources, etc., to the unsheltered. Goldsboro currently has a limited supply of TBRA provided by 2 local Public Housing Authorities, Housing Authority of the City of Goldsboro, and Eastern Regional Housing Authority. Both entities were consulted and expressed the need for additional permanent supportive rental housing resources.

Identify any gaps within the current shelter and housing inventory as well as the service delivery system:

A gap in the current shelter inventory is apparent. Goldsboro has 1 local shelter, provided by a church, that charges a small weekly fee for occupancy. Goldsboro does not have any non-congregate shelter units. Another local shelter, serving men only and operated by The Salvation Army, has been closed for the past three years. Efforts to assist the new leaders of the organization to reopen the shelter with other available HUD dollars have been unsuccessful. As data shows, there is an unmet need for the city's 31 unhoused.

Regarding the housing inventory, data gathered from the *Snapshot of Housing in North Carolina* provided by the North Carolina Housing Finance Agency shows that, of the total number of households (48,343), 18,311 of residents are renters and 30,032 of residents are homeowners in Wayne County.

Data supports the fact that Wayne County's housing inventory is aging and can therefore, support that there is a gap in the current housing inventory. According to the housing inventory snapshot above, 45% of housing units in the county were built in 1979 or earlier.

The table above is reflective of housing within the city limits of Goldsboro and shows an estimated 16,435 housing units within the city.

According to Goldsboro's recent *Analysis of Impediments to Fair Housing Choice*, completed May 2021, recommendations were made to preserve the city's current affordable housing stock and increase new affordable housing. The document also references that the lack of affordable housing Goldsboro is facing is partly due to "high costs, availability of land, and diverse sites in low poverty high-opportunity areas." Additionally, according to the *Analysis of Impediments to Fair Housing Choice*, available housing within the city is also aging with "about 6.6% of houses built before 1940, 38.0% between 1940 and 1969, 40.7% between 1970 and 1999, and 14.7% built 2000 or later."

While the lack of affordable housing has been identified, the City has determined that it will continue to use its CDBG and HOME entitlement funds to fund projects that will address this need. The City's HOME-ARP funding will be used to fill the gap in shelter resources by funding a non-congregate shelter for all qualifying populations. In addition, the City will use HOME-ARP funds to fund supportive services to support coordinated entry activities in the community. This will allow the City to improve on identifying and coordinating services and resources available to serve all qualifying populations. These efforts will ultimately improve access to housing for all qualifying populations.

There is a not a designated Coordinated Entry location in Goldsboro, evidence of a gap in Goldsboro's service delivery system. Although the Region 10 Balance of State Continuum of Care provides a Coordinated Entry process, the Coordinated Entry Lead is in Wilson, NC. This could be identified as a service delivery gap. City staff has recently reached out to the Region 10 CoC Lead and discussed the possibility of establishing a Coordinated Entry location in

Goldsboro. City staff have also recently joined the Region's Coordinated Entry team and will begin attending their weekly meetings this month.

Identify the characteristics of housing associated with instability and an increased risk of homelessness if the PJ will include such conditions in its definition of "other populations" as established in the HOME-ARP Notice:

The City of Goldsboro will not further identify "other populations."

Identify priority needs for qualifying populations:

• Homeless –

Priority needs for these qualifying populations remain consistent. There is an immediate need for a non-congregate shelter for Goldsboro's 31 identified unsheltered individuals experiencing homelessness. Additionally, as a result of an online survey, respondents were asked to rank the eligible activities from highest priority to lowest. 75% of the respondents identified Non-Congregate Shelter as the highest area of need in Goldsboro.

• At risk of homelessness-

This population was not identified.

• Fleeing/Attempting to Flee Domestic Violence, Dating Violence, Sexual Assault, Stalking, or Human Trafficking-

Overall, there is a great need for affordable housing that can help prevent homelessness for this population. Additionally, Goldsboro could benefit from additional resources such as rental assistance and more rental housing vouchers to assist other families requiring services, per consultations from local agencies.

• Other Populations –

This population was not identified.

Explain how the PJ determined the level of need and gaps in the PJ's shelter and housing inventory and service delivery systems based on the data presented in the plan:

The level of need and gaps described in this plan were determined through a robust community engagement process. Survey results showed that 75% of the respondents identified the Non-Congregate Shelter as the highest area of need in Goldsboro. The level of need was also determined by consultations with local provider agencies. Of the 19 agencies consulted, 9 expressed the need for more affordable housing and 5 expressed the need for a non-congregate shelter.

Comprehensive Housing Affordability Strategy (CHAS) and American Community Survey (ACS) data was analyzed to determine cost burden households where the natural housing market is not producing housing affordable to their incomes. Additionally, data from the North Carolina Housing Finance Agency and Goldsboro's recent *Analysis of Impediments to Fair Housing Choice* provided evidence that more housing is needed. These conclusions were further

supported through community consultations with agency providers and community members who identified the need for additional affordable housing.

The Point in Time Count and Housing Inventory Count reports were used to compare system capacity with household need. Additionally, the City collected data from the Goldsboro Police Department and was able to identify a substantial number of unsheltered individuals within the city who are in desperate need of shelter and supportive services.

HOME-ARP Activities

The City of Goldsboro will not administer eligible activities directly but rather seek qualified community entities to carry out the eligible activities. All funding awards will follow 2 CFR 200 procurement guidelines. The City will issue either Request for Proposals (RFP) or Request for Qualifications (RFQ) to select partner agencies.

At the close of the procurement process, all submittals will be reviewed for completeness, eligibility, and their ability to deliver the specified activity to the priority populations listed in this plan. Proposals will be objectively scored by a qualified scoring committee. Grant awards will be approved by the Goldsboro City Council.

Additional narrative: After assessing local needs and gaps, the Goldsboro City Council voted to split the remaining funds, (minus the 15% for Administration & Planning), allocating 60% to Non-Congregate Shelter and 40% to Supportive Services.

Describe how the characteristics of the shelter and housing inventory, service delivery system, and the needs identified in the gap analysis provided a rationale for the plan to fund eligible activities:

Through various sources of data collection and consultations, the characteristics of the data show a lack in the overall housing stock in the area, affordable housing options, little to no shelter options for the homeless, and limited-service delivery systems that lack necessary resources.

With 31 unsheltered homeless individuals in Goldsboro, one (1) shelter designated for victims of domestic violence, one (1) additional shelter that charges a weekly fee, and no other shelter options, Goldsboro is in dire need of a non-congregate shelter. Additionally, with the pressing need for affordable housing, which would aid in preventing homelessness, supportive services could also serve as an essential provision to assist with those transitioning from the shelter with more permanent and affordable housing solutions.

The City of Goldsboro will not produce or support rental housing units with its HOME-ARP allocation.


